- The annual MCC Membership fee will fall due on the 31st January 2017.
- **All riders must have ambulance cover and be licensed with Motorcycling Victoria.**
- **Single membership** is \$50.00
- **Family membership** is \$90.00
- Riders must wear full-faced helmet, goggles, gloves sturdy boots (no laces), long sleeve shirt and long pants, with NO EXPOSED SKIN. Parents/Guardians must be present while participating in a MMC club day.
- Motorcycling Victoria (M.V.) offers a Recreational rider licence. This provides Insurance and Public Liability cover during our club day, costing \$100.00. This licence also allows the riders to ride on other M.V. affiliated Motocross tracks during their practice days. MV Licence Application forms are available on the M.V. website @ www.motorcyclingvic.com.au or see the Club Secretary. These forms must be signed by the club's secretary along with MMC's club stamp.

Club day fees:

- MMC member \$10.00 per rider or
- Pay \$80 per rider to cover all 2017 club days (Club Preferred)
- NON Member \$20 – per rider
- Plus \$30.00 for MV Day Licence if rider is unlicensed
